

Offers by volunteers

Language courses, conversation teams or leisure opportunities.

„Erstorientungskurse“ (Initial orientation course) for asylum seekers

It is a three months` language course (A1) with country information.

Integrationskurs (Integration Course)

Persons with „Gestattung“ can attend an **Integration Course**. You have to apply for this course. Language schools or **counselling centers** (such as from FiBA+) will help you to apply.

Profession-oriented German course

This is often a German course for advanced learners (B2, C1). You can receive the permission through the employment agency (Agentur für Arbeit). To do so you have to report there that you are looking for a job. For ANKER inhabitants this is possible only after 6 months.

School

After staying three months in the ANKER, minors (6-18 years) and those of vocational school age (up to 21 years) have the right to attend school. Often school takes place in the ANKER-Center.

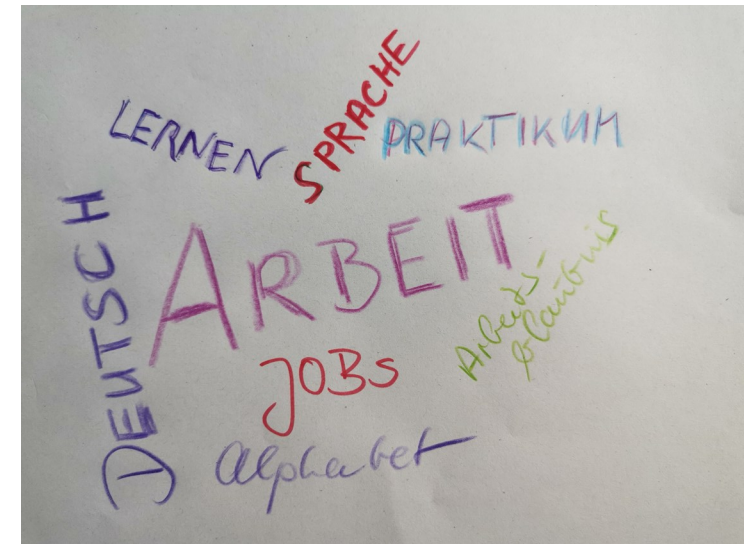

OPPORTUNITIES:

German language and work in ANKER-Centers



WORK

For work, internships and vocational training (Ausbildung) you need a working permit by the central foreigners` authority (Zentrale Ausländerbehörde (ZAB)).

The following occupations are possible without limitation and without permission by the foreigners` authority:

Volunteer work

A small amount of compensation is possible through a volunteering allowance up to 250 € per month (§ 7 Abs. 3 S. 2 AsylbLG). This allowance will not be deducted from the monthly asylum seekers` benefits.

Hospitation

This aims at learning about a specific type of work by watching only. This is an option, if internships are not possible due to a labour ban.

0,80€-Jobs

These are jobs that are offered through the regional government (such as jobs in the kitchen or in the cleaning team).

Working permit after 6 months since asylum application with „Gestattung“

After 6 months` stay in the ANKER you have also with „Gestattung“ the right to get a work permission. With this permission you can work, start a vocational training (Ausbildung) and get yourself registered as seeking work at the labour agency. Then, the labour agency can finance the certificate recognition. For each single job offer, you have to apply at the foreigners` Authority for the work permission.

After 6 months stay with „Duldung“

The foreigners` authority should issue a work permit, but they do not have to.

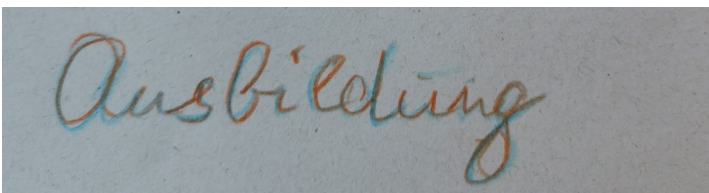
With unresolved identity: Working is not allowed.

This does not apply to persons in the Dublin process or from „safe countries of origin“. They can only work if they have a positive answer to the asylum process.

„Safe countries of origin“ are:

Senegal, Ghana, Albania, Kosovo, North Macedonia, Serbia, Bosnia and Herzegovina, Montenegro, Georgia and Republic of Moldova.

VOCATIONAL TRAINING (AUSBILDUNG)



Dual (job- and school based) Ausbildung

Good knowledge of German is important. The permission should be issued after 6 months` stay with „Gestattung“. You must search for a vocational training position on your own. Counselling centers can support you in searching. Internships or hospitations can be helpful in getting a position. Part time vocational trainings are also possible.

School-based vocational training

This training is possible **without the permission** of the foreigners` authority, as soon as your German is good enough, and if the internship part is not more than 90 days per school year (e.g. social welfare care, child care, supply and nutrition).

RECOGNITION OF CERTIFICATES

Even before the work permit, it could be checked if the recognition of certificates is necessary and which documents could be obtained from the home country. FiBA+ Counselling centers help you in this process.

COUNSELLING AND SUPPORT THROUGH FiBA+

We urgently advice you to seek counselling, in order to receive support and information based on your individual situation. FiBA+ accompanies you also in looking for language courses, vocational training and work.
